In addition, a transfer service is provided which provides patient transfers to medical facilities from Boston, Massachusetts to Bangor, Maine. Finally, we provide a wheelchair van service for medical and non-medical transportation to facilities within our service area. All services are provided through our stations located in York, Maine and South Berwick, ME.
